done in managing the process.

8. COUNCILLORS' REPORTS:

8.1 Cllr. Bill Rowlands

IOACC had responded to his request for details of cost for the installation of a traffic control sign at the Holyhead end of Trearddur Bay village (on the B4545). There were two types of signage available:

600mm Speed Limit Roundel – a circular sign which illuminates to show the limit in force – cost £1,600

'Speed limit above safety message' this was a larger sign - cost £1,850.

Both types of signs would come with a 24 month warranty. Should the Community Council wish to proceed and purchase a sign then the County Council would arrange and pay for the installation.

Resolved: to ask IOACC to install the larger sign as the stretch of road leading up to the Golf Club entrance was notoriously dangerous and the risks would increase as more properties were being built on that lane.

Cllr. Rowlands also reported on a Community and RSPB Meeting he had attended on 21.2.19 to discuss the parking at South Stack. It was proposed that local residents should be offered a concessionary rate of £20 per annum and that general charges should be:

High season £2.50 for an hour and £5.00 for the day

Low season £1.50 for an hour and £3.00 for the day.

RSPB's had not yet responded to the questions asked.

8.2 Cllr. Keith Roberts

Had reported a problem with the street lighting – this was now resolved.

Notified the Council that the Burial Board would be meeting at 11am on 11.3.2019 to provide representatives with an update. Cllr. McDermott expressed her concerns that the meetings had been changed to the mornings, this meant that she could no longer attend which left the Community Council under-represented. This was matter of concern as TCC contribute a substantial amount to the upkeep of the cemetery. It also became apparent that TCC did not have a copy of the HJBC's constitution. Cllr. Keith Roberts would arrange for the clerk to receive a copy.

8.3 Cllr. Eric Roberts

Reported that a new BT connection was to be installed at the Village Hall and quotes had been requested for the upgrading of the toilets and partial resurfacing of the car park.

The outside light was still faulty - either the top or bottom light wasn't working. The Community Council would be asked to pay for repairing this.
