Presentation: Holy Island Landscape Partnership : Efan Milner a Bethan Morris

The Partnership had been set up 4 years previously with a 1.5 million from the Heritage Lottery Fund to work together with communities to raise awareness and appreciation of Holy Island's historic character and natural heritage. The partnership was made up of 6 informal working groups; Access, Education, Landscape Character, Natural Heritage, Community Activities and Interpretation. The groups were supported by stakeholders with specific knowledge, skills & expertise do deliver on their particular projects and initiatives. These stakeholders included organisations such as the Isle of Anglesey County Council, CADW, RSPB, Gwynedd Archaeological Trust, Natural Resources Wales, North Wales Wildlife Trust, Menter Iaith and many more.

The projects already started included Caffi Cybi, working with outdoor activity providers , working around Hut Circles on Mynydd Twr, Interpretation Projects, Guided Walks and Small Grants for Businesses.

Grants of up to £2,000 were being made available every year for local people to work together on projects such as interpretation, signposting, translation, artwork etc. that would and promote key features of the island and develop Holy Island as an international visitor gateway to Wales.

Council Members quoted a number of examples of potential projects that would be of interest in the community.

9. GOVERNANCE ISSUES

9.1 Code of Conduct:

The chairman reminded Members that Community Councillors had no individual authority or power to act on their own initiative. All matters of concern should be brought to the Council for a decision on the way forward. The Council is the legal body and its decisions are the responsibility of the whole body and members are required to abide by that decision. He also emphasised that the Council was not a policing body but Councillors were expected to report or deter illegal activity.

The clerk made reference to the guide issued by the Ombudsman on how to interpret the Code of Conduct and picked up some of the main issues identified in that document. These included:

- Declarations of interest and the differences between Personal / Prejudicial interest and dispensations. It was noted that Trearddur Community Councillors were generally well informed on these points and tended to err on the side of caution when declaring their interests.
- Proper and improper use of councillor position in terms of behaviour, perceived power - verbally and in writing.
- Disrepute

Each point was illustrated with examples of what constituted good and bad practice from the Ombudsman's guide and local procedures / experiences.
